Method of Bidding will be as follows:

UNIT PRICE CONTRACT for the installation of approximately 42,755 linear feet of water main which includes 39,605 linear feet of 8-, 6-, 4-, and 3-inch PVC water main installed by open trench methods, and 3,440 linear feet of 8-, 6-, 4- and 3-inch PVC water main installed by horizontal directional drilling, 294 linear feet of 14-, 12-, 8-, and 6-inch steel casing pipe installed by boring and jacking, 21 gate valves, 14 fire hydrant assemblies, 13 manual air release assemblies, eight 2-inch flushout assemblies, 35 customer service connections, a tie-in to the existing water distribution system, and other appurtenances necessary to complete the **CHANDLERSVILLE EAST WATER MAIN EXTENSION** as specified herein and shown on the CONSTRUCTION DRAWINGS.

The Cost Estimate for this contract is \$ 1,375,000.00

Bidding documents may be obtained from the Muskingum County Project Department, 401 Main Street, First Floor, Zanesville, Ohio, 43701 between the hours of 8:30 a.m. and Noon and 1:00 p.m. and 4:30 p.m., Monday through Friday, excluding holidays.

A non-refundable deposit shall be required for the bidding documents in the amount of **\$150.00** with checks payable to the Muskingum County Treasurer. This deposit is required before the documents can be made available.

The Owner reserves the right to waive any informality or to reject any and all Bids.

Each Bidder must submit with his Bid, security in the amount, form and subject to the conditions provided in the Instruction for Bidders.

All work done under this contract shall be subject to all Federal Davis Bacon Wage rates and rules.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each Bidder must submit evidence of its experiences on projects of similar size and complexity.

All Contractors and subcontractors involved with the project will, to the extent practicable use Ohio Products, materials, services, and labor in the implementation of their project. Additionally, Contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

The Contractor shall not discriminate on the basis of race, color, national origin or sex in the performance of this contract. The Contractor shall carry out applicable requirements of 40 CFR Part 33 in the award and administration of contracts awarded under EPA financial assistance agreements. Failure by the Contractor to carry out these requirements is a material breach of this contract which may result in the termination of this contract or other legally available remedies.

This procurement is subject to the EPA policy of encouraging the participation of small business in rural areas (SBRAs).

Domestic iron and steel use requirements as specified in P.L. 113-76, "Consolidated Appropriations Act, 2014" apply to this project.
